National Trade Supply, LLC Order Details Agreement

1. **Minimum Orders:** Minimum Order accepted is \$300.00, not including freight or taxes.
2. **Prices:** Prices are subject to change or corrected without notice.
3. **Taxes:** Quoted prices are exclusive of all taxes unless otherwise stated. Purchaser shall be responsible for payment of all applicable state and local taxes. Orders shipped within Indiana may be subject to applicable state tax rates unless a completed reseller's exempt certificate is on file.
4. **Shipping:** Quoted prices are exclusive of all shipping costs unless otherwise stated. Purchaser shall be responsible for payment of all shipping costs line itemed on final invoice.
5. **Terms:** If customer is approved for credit terms, terms of payment on open accounts are NET 30 days from the date of the invoice, unless otherwise stated and mutually agreed upon by both parties. Terms will only be issued to companies that reside in the USA. Interest will be charged on past due accounts. Interest charges will be the lesser of the unpaid balance at 3% per month (36% annum) and the maximum rate allowed by law. All questions regarding invoices and terms must be addressed with National Trade Supply's accounting department before invoices become due.
6. **Returns:** A Return Merchandise Authorization must be obtained from National Trade Supply, LLC before any returns can be shipped or accepted. An RMA must be filled out completely and sent with the returned merchandise. Items not in new condition and in original packaging are non returnable. Special or custom ordered items are non returnable.
7. **NSF Checks:** There is a \$25.00 charge for all NSF checks.
